Administering Agency:

Office of the Attorney General

Eligible Uses (Code of Criminal Procedure, Art. 56B.453):

- Office of the Attorney General
 - Crime Victims' Compensation claim payments.
 - Emergency Reserve
 - Victims Assistance Grants
- Other Agencies
 - Programs related to victim services or assistance.

Primary Revenue Sources:

- Court Costs (Local Government Code, Sec. 133.102)
- Parole Fees (Government Code, Sec. 508.182)
- Inmate Fees (Government Code, Sec. 495.027)


Restrictions (Code of Criminal Procedure, Art. 56B.454):

- The Office of the Attorney General may not make compensation payments that exceed the amount of money available in the fund.
- General Revenue may not be used for CVC claim payments.

Potential Solutions

Increase revenues:

- Modify fee allocations
 - GR-D 0469: court cost fees, parole fees, prison inmate phone fees;
 - GR-D 5010: sexually oriented business fees, court fines, administrative fees;
- Create additional revenue sources
- Appropriate GR for transfer to the accounts. The 87th Legislature used this approach and appropriated the following amounts for transfer to Funds 469 and 5010:
 - GR-D 0469: \$43,155,529 in GR (GAA) and \$54,756,000 in Coronavirus Relief Fund 325
 - GR-D 5010: \$26,061,279 in GR (GAA) and \$52,277,114 in Coronavirus Relief Fund 325

Reduce Appropriations/Expenditures:

- Implement method of finance swaps at recipient agencies to reduce funding out of GR-D 0469 & GR-D 5010.
- Reduce appropriations for affected programs.
 - Note that certain payments made for CVC claims are based on statutorily required reimbursements.

Other:

Modify statute to allow for GR to be use for CVC claims.
