HR 6074 was signed into law on March 6, 2020, and provided approximately \$8.3 billion for emergency funding for federal agencies and state and local entities to respond to the initial COVID-19 outbreak. The bill included financial support to address the impact of COVID-19 and the increased demands on the medical field including supplies, personal protective equipment, diagnostic equipment, and supplies; countermeasures to address potential supply chain disruptions; and small business loans.

Notes:

- Amounts reflected above are as of November 30, 2022, as reported by state agencies and institutions of higher education. Amounts are subject to change based on final awards, expenditures, and obligations between reporting periods. Awards sent directly to locals from federal agencies are not included in this report.
- Missing information was not available at the time of current survey November 30, 2022.
- Public Assistance grants are awarded by federal reimbursements. The Texas Division of Emergency Management is the state administrator. Due to the nature of the awards, TDEM pass throughs and state agencies reporting awards received may not be accurate.
