OFFENSES AND DEMOGRAPHICS OF JUVENILES IN STATE-OPERATED CORRECTIONAL FACILITIES, FISCAL YEAR 2012

OBJECTIVE

This brief provides a profile of juveniles in state-operated correctional facilities at the end of fiscal year 2012. In the first three months of fiscal year 2012 these facilities were operated by the Texas Youth Commission (TYC). That agency was abolished and merged along with the Texas Juvenile Probation Commission into the newly created Texas Juvenile Justice Department (TJJD) by SB 653, which was passed by the 82nd Texas Legislature and signed by the TJJD was created on Governor. December 1, 2011, and provided for the administration of state-operated juvenile correctional facilities for the last nine months of fiscal year 2012.

KEY FACTS

- The most common offenses for juveniles in state-operated correctional facilities were assault (22.7 percent), sex offenses (16.7 percent), burglary (15.7 percent) and robbery (15.6 percent).
- ♦ 62.6 percent of juveniles were committed for first or seconddegree felonies.
- ◆ 61.0 percent of juveniles were 16 or 17 years old, 78.4 percent were African American or Hispanic, and 91.3 percent were male.

STATUTORY REFERENCES

TYC was authorized by Human Resources Code, Chapter 61. TJJD was authorized by Human Resources Code, Chapter 201. The Human Resources Code indicates one of the purposes of the Texas Youth Commission (TYC, now Texas Juvenile Justice Department (TJJD)) was to provide for administration of the state's correctional facilities for children and to provide a program of constructive training aimed at rehabilitation of juveniles committed to TYC. The information below provides a description of the offenses and demographics of juveniles in state-operated correctional facilities as of August 31, 2012.

OFFENSES

Fig. 1 shows the most common offenses for juveniles in state residential facilities were assault, sex offenses, burglary, and robbery. These four offenses account for 70.7 percent of all juveniles in state residential facilities as of August 31, 2012.

Eight juveniles (0.6 percent) were committed for a capital felony, 382 (26.7 percent) were committed for a first-degree felony, 514 (35.9 percent) were committed for a second-degree felony, 301 (21.1 percent) were committed for a third-degree felony, and 225 (15.7 percent) were committed for a state jail felony.

DEMOGRAPHICS

Fig. 2 shows that 61.0 percent of juveniles in state-operated correctional facilities on August 31, 2012, were either 16 or 17 years old.

Fig. 3 shows that 78.4 percent of juveniles in state-operated correctional facilities on August 31, 2012 were either African American or Hispanic.

A total of 91.3 percent (1,306) of those in state-operated correctional facilities on Aug. 31, 2012, were male, while 8.7 percent (124) were female.
